Forest Hero: Paulo Adario

Paulo Adario, who heads up Greenpeace's Amazon campaign, was recently awarded the honor of "Forest Hero" at the United Nations ceremony for the Year of the Forests in New York.

His story in the Amazon began with his decision to move to Manaus in the mid-1990s. It was here that he built, from scratch, the Greenpeace campaign to defend the Amazon Rainforest.

Leading a field team focused on research and investigation, Adario's work exposed the timber industry as the first in a number of drivers of destruction in the Amazon Rainforest.

Adario also introduced new concepts, such as the "Green Wall" to describe the network of protected areas necessary to stop the northern encroachment of industrial development, and "Zero Deforestation"—a set of political, social and economic initiatives aimed at eliminating deforestation while ensuring the improvement of living conditions for people living in and from the forests.

The impacts of Adario's work have attracted death threats from

forest criminals across the Amazon. Despite this, he persisted and went on to create bilateral agreements with international and industrial companies to halt the illegal destruction of the forests for soya crops and cattle ranching. The resulting soya moratorium and cattle industry agreements are still in place today.

Paulo Adario's career of Amazon protection is an inspiration to all of us and proof of what can happen when one person decides to take action.

YOUR CHILDREN

If your children are minors, you can use your will to recommend a guardian and make arrangements for management of the property you leave to them until they reach an age you specify.

If your children are adults, you can decide what share of your property you wish each child to have. One child may have greater needs than another. When there is no will, state laws tend to divide all assets equally.

OTHER HEIRS

If you do not have children, you may want to remember other relatives or special friends.

Without a will or other legal arrangements, no one outside your family will receive any of your property. And only those related to you in prescribed ways can inherit.

Add a Charitable Dimension

There are many ways to include charitable gifts as part of your estate plans. Here are examples of the various forms a charitable gift can take:

Residue. This is a gift of what remains in an estate after all other distributions have been fulfilled.

Percentage. Providing that a certain percentage of your estate be used for charitable purposes allows your gift to remain in proportion to the size of your estate.

Specific amount. A specific dollar amount may be given. This can be useful when you wish to fund a particular need.

Specific property. It can be smart tax planning to leave certain properties of value to charitable recipients.

Contingent. This gift only occurs under certain circumstances, such as the prior death of a loved one. Greenpeace is often named as a contingent

beneficiary to receive property when heirs are not there to do so.

Whatever form you prefer for your gifts, make certain the correct legal names of the intended recipients are used in order to avoid confusion and delay.

Gift Planning Pointers

- If you don't have a will, no cause or organization like Greenpeace can receive any property you may have intended for charitable use.
- Careful planning can help you make charitable gifts without sacrificing the future security of your loved ones.
- Charitable gifts to Greenpeace Fund can serve to eliminate tax on a portion of your income.
- Special benefits can result from gifts of retirement plan assets.

- Gifts of securities and other appropriate property that has increased in value can eliminate capital gains tax.
- Memorial gifts to honor persons special to you can be set up in a will or living trust.
- Redirecting life insurance proceeds for charitable purposes can be a convenient way to make a generous, cost-effective gift.



He carried over the love






His immense curiosity about the world explained
